

Donald Verrilli, a graduate of Yale College and Columbia Law School and a former law clerk to U.S. Circuit Judge J. Skelly Wright (D.C. Cir.) and U.S. Supreme Court Justice William J. Brennan, Jr., is an acclaimed American lawyer and courtroom advocate, including for arguing fifty cases in the U.S. Supreme Court.

Following two decades in private law practice, Mr. Verrilli served in the Obama Administration, first as Associate Deputy Attorney General, then as Deputy White House Counsel, and then as Solicitor General.

As Solicitor General, Mr. Verrilli, among other highlights, successfully defended the constitutionality of the Affordable Care Act, the legality of its implementation, and the constitutional protection of marriage equality.

Since 2016, Mr. Verrilli has been a partner in Munger, Tolles & Olson LLP, handling matters before the Supreme Court and the U.S. Courts of Appeals and representing and counseling clients on litigation, regulatory, and public policy problems.
