Sixty-Six Years Since Brown

The Court—Chief Justice Earl Warren and eight Associate Justices, including Robert H. Jackson—held unanimously that government segregation by race of school children was, henceforth, barred by the U.S. Constitution. The Court declared that state government school segregation was barred by the Fourteenth Amendment's Equal Protection Clause, and that federal government school segregation was barred by the Fifth Amendment's Due Process Clause.
